SCGF SMS alerts

Sugar Cane Growers Fund (SCGF) SMS alerts is an automated information service provide to existing customers which gives you access to selected transaction and balance information about your account (s) using a Short Message Service (SMS) sent to your mobile phone.

You can choose the following options of the services:

TERMS & CONDITIONS

Fees for SMS Alerts

SMS alert sent through Vodafone will be charged \$0.10 per SMS and through Digicel is \$0.15 which is subject to change from time to time. This will be advised and prescribed in **SCGF's schedule of Fees and Charges**. The fee will be debited to loan account when opened by 15th of following month and same will be paid to telecommunication provider.

SCGF does not charge any extra fee for this service.

There is no fee applicable to any message sent through email.

For any change to the Alert Services, you have to contact SCGF or visit the nearest District Office.

Reliance on SMS Alerts

SMS alerts are available seven days a week, but may not be available when we're processing end-of-day transactions (generally between 4.30pm in the weekdays). SCGF will make all reasonable efforts to ensure the availability, accuracy and currency of SMS alerts, but we are not liable if the SMS alerts service is not available, is inaccurate, or is experiencing delays or errors, and we do not accept liability for any loss that you suffer as a result of a problem with SMS alerts.

You should not rely solely on SMS alerts to manage your accounts and you should check your statements of account for any discrepancies or any of the District Offices.

Cancelling or Change of Reregistration for SMS alerts.

We can cancel your registration for SMS Alerts or Change at any time for those optional services. For that, you have visit or contact our District Office.

Changes to SMS Alerts Terms & Conditions

We may change these terms and conditions from time to time, including the fees payable, alerts and information available, and accounts that can be accessed.

We will give you notice of any changes to the terms and conditions in writing, electronically, or by advertisement in the media. If we increase or introduce a fee, we will give you at least 30 days' notice. We will give you notice of other changes no later than the day they take effect.

Privacy and security.

Warning: SMS messages may not be secured. If you have concerns about your transaction and balance information being sent by SMS message, you should not register for SMS alerts. We recommend you protect your information by keeping your mobile phone secured at all times and deleting your SMS messages after you have read them. SCGF takes no responsibility in case the Alert messages are generated and such message are accessed by a third party.

If you change mobile numbers or if your mobile phone is lost or stolen, you should cancel your registration for SMS alerts and re-register with your new mobile phone number at your nearest District office.
