Criteria and Guideline for Application:

- (a) Grant will be provided on a first come first serve basis.
- (b) Sugar Research Institute of Fiji (SRIF) assess farms if:
 - i) it's been fallow and nonproductive land,
 - ii) New land that has never been used for sugarcane cultivation.
- (c) The applications will be open on <u>1st November 2024 and close on 30 April 2025</u> (subject to review on availability of funds).
- (d) The applicant must submit the completed grant application form with accurate information and all supporting documents as required to the Ministry of Sugar Industry.
- (e) The applications will be evaluated as received by the Ministry of Sugar Industry.
- (f) Grant Conditions:
 - i. Grant is available to growers for lease renewals. They need to be issued offer letters for lease renewals from *i-Taukei* Land Trust Board, Lands Department or any other bona-fide lessor.
 - ii. The grant may apply for the purchase of sugar cane farm (only for new growers that purchase cane farms for the first time) with documents such as sales and purchase agreement, or transfer documents and loan agreement dated 2024 and 2025;
 - iii. The grant will not apply to the lease transaction between the immediate family members.
 - iv. For new farmers, the applicant should not own any agricultural land or agricultural lease under his\her name;
 - v. Only one applicant shall be assisted per household;
 - vi. The applicant should have the knowledge, experience, crop plan, and succession plan in the management of sugarcane farms;
 - vii. The land purchased should have a minimum of <u>10 acres</u> of sugarcane land for cane planting; and
 - viii. Selection of farmers under lease renewal is average minimum of 100 tonnes for last three years and;
 - ix. The farm needs to be strategically located.
- (g) The Ministry of Sugar Industry will pay only **30%** of the lease offer cost stated in the lease offer letter or a maximum of **\$7,500**; whichever is lower. A maximum payment limit for purchase of new farms is **\$7,500**.
- (h) The farm purchased or lease renewed under the New Farmers or Lease Renewal Program should not be sold in the next 5 years. In cases where the land is required to be sold before the end of 5 years, the grant assistance given to the applicant/grower must be paid back to the Ministry of Sugar Industry <u>in full</u> by the grower.
- (i) There will appropriate charge on the farm for the amount and any charges or out-of-pocket expenses will be deducted from the grant amount.
- (j) The farm is to be productive within 18 months from the time COR is issued.
- (k) The funds allocated in 2024/2025 financial year is **strictly** for grant assistance to farmers that will purchase land for farmers whose lease will expire between **2024 to 2025**.
